

## INFORMATION TO PROSPECTIVE AUTHORS

### Writing Style

For your manuscript to be considered for publication in the JNPARR, the writing style should be formal and scholarly. It should be written following the APA Style, 6th edition, for in-text citations and reference listing.

### Submissions

Manuscripts should be 12-15 pages, double-spaced, electronically submitted by email @ TheJNPARR@gmail.com, preferably using Microsoft Word.

### Graphics

The inclusion of pictures, tables and figures are encouraged, particularly if these will enhance the readability of the manuscript/ these should be camera-ready and in high resolution. Graphics should be properly labeled and titled, appearing at the bottom. Pictures, tables and figures are to be labeled as such. And should appear at the end of the manuscript (following the References listing).

### Assignment of Rights
